

**NOTICE OF ELIGIBILITY FOR COLLECTOR LICENCE A SPECIAL**

 Licence A, would like to inform the Commissioner of Police that, I would like to be issued with  
 a Collector Licence A Special for the following reason/s:

<p>I am the owner of short firearms, which are duly registered with the Commissioner of Police and which allow the firing of more than 21 rounds of ammunition without reloading since:</p> <ul style="list-style-type: none"> <li>i) a loading device with a capacity exceeding 20 rounds is part of the firearm; or</li> <li>ii) I am in possession of a detachable loading device with a capacity exceeding 20 rounds which can be inserted into it.</li> </ul>	
<p>I am the owner of long firearms which allow the firing of more than 11 rounds of ammunition without reloading since:</p> <ul style="list-style-type: none"> <li>i) a loading device with a capacity exceeding 10 rounds is part of the firearm; or</li> <li>ii) I am in possession of a detachable loading device with a capacity exceeding 10 rounds which can be inserted into it.</li> </ul>	
<p>I am the owner of Schedule I firearms duly registered with the Commissioner of Police under my Collector Licence A.</p>	

I am also requesting the Commissioner of Police that in the case of:

- 1) Short firearms, which are duly registered with the Commissioner of Police, where a loading device with a capacity exceeding 20 rounds is part of the firearm;
- 2) Long firearms, which are duly registered with the Commissioner of Police, where a loading device with a capacity exceeding 10 rounds is part of the firearm; and
- 3) These firearms are indicated in the attached list;

the same Commissioner of Police takes the necessary measures to re-schedule these firearms, so that these are compliant with the requirements of the Arms Act (Amendment of Schedules I,II and III) Regulations, 2018.
